We can help you with customized solutions for shredding, de-packaging, or resizing your materials so that maximum value is extracted prior to disposal. Our facilities are equipped to receive materials in a wide variety of containers and packaging including: bulk, boxed, drums, totes, bails, pallets, and slip sheets with easy unloading for transport trailers including: vans, self-unloading, end-dumps, and bulk tankers.

On average, our facilities perform 60-80% better than what is allowed by our permits and feature both ferrous and nonferrous metal recycling. In addition, depending on your specific materials, EfW can offer significant greenhouse gas and other lifecycle benefits, resulting in significantly less environmental impact than if those materials were sent to a landfill. In some cases, renewable energy and carbon offset credits are also available.

Materials received at our facilities are normally processed within 24 hours by using an advanced combustion technology that exposes them to temperatures of approximately 2000° F. The result is molecular destruction of your materials with any residual rendered completely inert. This means that within 24 hours, your long-term environmental liability exposure is virtually eliminated. Contrast that to other disposal options that can expose you to extended liability such as landfills, where your materials can remain intact for hundreds of years.
